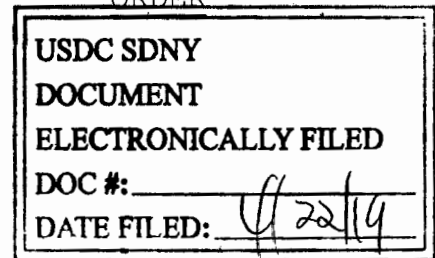

ORDER



JED S. RAKOFF, U.S.D.J.

The parties in the above-captioned cases have jointly requested that the Court extend several deadlines in the case management schedule governing all consolidated cases. The Court hereby grants the parties' request, but absolutely no further

extensions will be granted. The deadlines in the case management plan are extended as follows:


- Requests to Admit, if any, must be served by August 16, 2019.
- All fact depositions must be completed by September 6, 2019.
- All discovery other than expert discovery is to be completed by September 6, 2019.
- Every party-proponent of a claim (including any counterclaim, cross-claim, or third-party claim) that intends to offer expert testimony in respect of such claim must make the disclosures required by Fed. R. Civ. P. 26(a)(2) by September 13, 2019.
- Every party-opponent of such claim that intends to offer expert testimony in opposition to such claim must make the disclosures required by Fed. R. Civ. P. 26(a)(2) by September 27, 2019.
- Post-discovery summary judgment moving papers must be served by October 2, 2019.
- All expert depositions must be completed by October 16, 2019.

- Post-discovery summary judgment answering papers must be served by October 18, 2019.
- Post-discovery summary judgment reply papers must be served by October 25, 2019 and may incorporate expert deposition testimony not available when moving papers are filed.
- The case shall be ready for trial by October 28, 2019, though the actual trial date will be set hereinafter.
- A final pre-trial conference, as well as oral argument on any post-discovery summary judgment motions, shall be held on November 4, 2019 at 10:00 AM.

In addition, the Court hereby grants the request of certain parties in Trott et al. v. Platinum Management (NY) LLC et al., over the Trott plaintiffs' objection, to extend the deadline to join additional parties in that case to May 15, 2019.
