

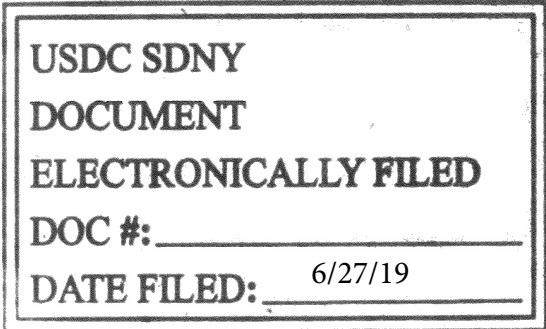

ORDER



JED S. RAKOFF, U.S.D.J.


On December 19, 2018, plaintiff Melanie L. Cyganowski filed a multi-count Complaint against numerous defendants. ECF No. 1. On March 27, 2019, defendants Bankers Consec Life Insurance Company ("BCLIC") and Washington National Insurance Company ("WNIC") filed an Answer, Cross-Claims, and Third-Party Complaint ("BCLIC-WNIC TPC"). ECF No. 75. On March 29, plaintiff filed a First Amended Complaint ("FAC"). ECF No. 81. And on May 15, defendants Senior Health Insurance Company of Pennsylvania

and Fuzion Analytics, Inc. filed an Answer, Cross-Claims, and Third-Party Complaint ("SHIP-Fuzion TPC"). ECF No. 195.

Oral argument on motions to dismiss the FAC and BCLIC-WNIC TPC - which was previously scheduled for July 11, 2019 - and oral argument on motions to dismiss the SHIP-Fuzion TPC - which was previously scheduled for July 26, 2019 - are hereby consolidated and rescheduled for August 12, 2019 at 9:00 AM. In addition, the Court will no longer hear argument on BCLIC and WNIC's Motion to Enforce State Security Statutes, ECF No. 244, but will instead decide that motion on the papers.
