


Joseph Grekin, being duly sworn hereby deposes and says as follows:



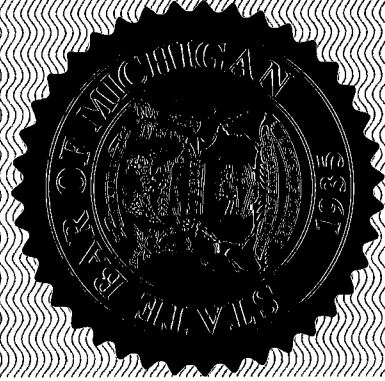
