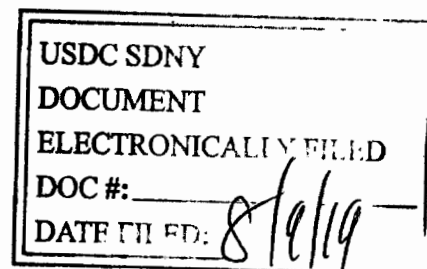

3. "There are no disciplinary proceedings presently against me."

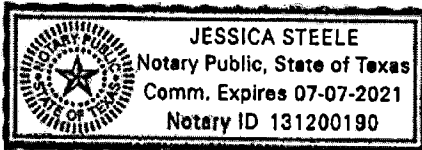
