474. The claims alleged in the ATPC against Kevin Cassidy are barred, in whole or in part, because Plaintiffs lack standing under the doctrine established in *Shearson Lehman Hutton*, *Inc. v. Wagoner*, 944 F.2d 114, 120 (2d Cir. 1991).

### **Fourth Affirmative Defense**

475. The Seventh Count against Kevin Cassidy is barred because the unjust enrichment claim is duplicative of the alleged tort claims and/or an express contract governs the transfer of assets from PGS to Starfish Capital, Inc. in connection with the alleged "Agera Transactions."

#### Fifth Affirmative Defense

476. The claims alleged in the ATPC against Kevin Cassidy are barred, in whole or in part, because SHIP failed to mitigate its claimed damages.

## **Sixth Affirmative Defense**

477. The claims alleged in the ATPC against Kevin Cassidy are barred, in whole or in part, because SHIP lacks standing to pursue the claims.

## **Seventh Affirmative Defense**

478. The claims alleged in the ATPC against Kevin Cassidy are barred, in whole or in part, because SHIP consented to and/or ratified the conduct alleged to have been wrongful.

## **Eighth Affirmative Defense**

479. The claims alleged in the ATPC against Kevin Cassidy are barred, in whole or in part, by the doctrine of waiver.

# **Ninth Affirmative Defense**

480. The claims alleged in the ATPC against Kevin Cassidy are barred, in whole or in part, by the doctrine of estoppel.

## **Tenth Affirmative Defense**

481. The claims alleged in the ATPC against Kevin Cassidy are barred, in whole or in part, by the doctrine of laches.

# **Eleventh Affirmative Defense**

482. The claims alleged in the ATPC against Kevin Cassidy are barred, in whole or in part, by the doctrine of unclean hands.

## **Twelfth Affirmative Defense**

483. The relief sought in the ATPC is barred, in whole or in part, because of any loss or damage sustained by SHIP was occasioned by the acts, omissions, and/or conduct of persons and/or entities over whom Kevin Cassidy exercised no control.

## **Thirteenth Affirmative Defense**

484. The claims alleged in the ATPC against Kevin Cassidy are barred, in whole or in part, because Kevin Cassidy owed no duties to SHIP at any relevant time.

# **Fourteenth Affirmative Defense**

485. SHIP's claimed damages are limited, in whole or in part, by the doctrine of setoff.

# **Fifteenth Affirmative Defense**

486. SHIP's alleged damages, if any, are too speculative and too remote.
