480. Slota reserve his right(s) to assert any and other defenses as discovery may reveal or may be directed with respect to the ATPC or any amendment thereto.

WHEREFORE Third-Party Defendant Slota respectfully request that the ATPC be dismissed in its entirety as against him, and that fees, costs and disbursements and attorneys' fees be remitted to Slota for defending this action, together with such other and further relief as this Court deems just and proper.
