- 961-67. Paragraphs 961 through 967 contain legal conclusions to which no response is required. To the extent a response is required, Landesman lacks knowledge or information sufficient to form a belief as to the veracity of the allegations set forth in Paragraphs 961 through 967 and therefore denies such allegations.

Seventeenth Count: Violation of Civil RICO against the Platinum Defendants and the Beechwood Defendants

- 968. Landesman repeats and re-alleges its answers to Paragraphs 1-967 as if fully set forth here.
- 969-85. This claim was dismissed by the Court on June 21, 2019 (18-6658, Dkt. 488), and therefore no answer is required.

Eighteenth Count: (For Relief Only) Alter Ego against the Beechwood Entities in respect of Counts One, Two, Four and Five

- 986. Landesman repeats and re-alleges its answers to Paragraphs 1-985 as if fully set forth here.
- 987-1000. Paragraphs 978 through 1000 relate to a claim that is not asserted against Landesman, and therefore no response is required.

Nineteenth Count: (For Relief Only) Alter Ego against the BEOF Funds in respect of Counts One, Two, Four and Five

- 1001. Landesman repeats and re-alleges its answers to Paragraphs 1-1000 as if fully set forth here.
- 1002-12. Paragraphs 1002 through 1012 relate to a claim that is not asserted against Landesman, and therefore no response is required.

Twentieth Count: Declaratory Judgment The Nordlicht Side Letter is Void and Unenforceable as Contrary to Public Policy

- 1013. Landesman repeats and re-alleges its answers to Paragraphs 1-1012 as if fully set forth here.
- 1014-17. Landesman lacks knowledge or information sufficient to form a belief as to the veracity of the allegations set forth in Paragraphs 1014 through 1017 and therefore denies such allegations.
- 1018-20. Paragraphs 1018 through 1020 contain legal conclusions to which no response is required. To the extent a response is required, Landesman lacks knowledge or information sufficient to form a belief as to the veracity of the allegations set forth in Paragraphs 1018 through 1020 and therefore denies such allegations.

Twenty-First Count: Declaratory Judgment that the Master Guaranty is Void and Unenforceable as Contrary to Public Policy

- 1021. Landesman repeats and re-alleges its answers to Paragraphs 1-1021 as if fully set forth here.
- 1022-24. Landesman lacks knowledge or information sufficient to form a belief as to the veracity of the allegations set forth in Paragraphs 1022 through 1024 and therefore denies such allegations.
- 1025-28. Paragraphs 1025 through 1028 contain legal conclusions to which no response is required. To the extent a response is required, Landesman lacks knowledge or information sufficient to form a belief as to the veracity of the allegations set forth in Paragraphs 1025 through 1028 and therefore denies such allegations.

Twenty-Second Count: (For Relief Only) Alter Ego against the Huberfeld Family Foundation in respect of Counts One, Two, Four and Five

1029. Landesman repeats and re-alleges its answers to Paragraphs 1-1028 as if fully set forth here.

1030-41. Paragraphs 1030 through 1041 relate to a claim that is not asserted against Landesman, and therefore no response is required.

ANSWER TO THE PRAYER FOR RELIEF

Landesman denies that Plaintiffs are entitled to any damages or relief sought in the WHEREFORE clause of the Second Amended Complaint or to any other relief.

Landesman denies each and every allegation in the Second Amended Complaint not specifically admitted herein.

AFFIRMATIVE DEFENSES

In further answer to the Second Amended Complaint, and as separate and distinct affirmative and other defenses, Landesman asserts the following defenses. In asserting these defenses, Landesman does not assume the burden of proof as to matters that, pursuant to law, are Plaintiffs' burden to prove.

First Affirmative Defense

The Second Amended Complaint as a whole, and each purported cause of action alleged therein, fails to state facts sufficient to constitute a cause of action against Landesman upon which relief can be granted.

Second Affirmative Defense

Plaintiffs' claims are barred, in whole or in part, by the doctrines of unclean hands, estoppel, assumption of the risk, contributory or comparative negligence, waiver, and/or laches.

Third Affirmative Defense

At all times, Landesman performed its obligations under any duly executed agreements in

good faith and in compliance with federal and state law.

Reservation Of Additional Defenses

Landesman currently has insufficient information upon which to form a belief as to

whether it may have additional, as yet unstated, defenses beyond those listed above. Landesman,

therefore, reserves the right to assert additional defenses as appropriate.

WHEREFORE, Landesman prays for judgment as follows:

1. Plaintiffs take nothing on their Second Amended Complaint, that the Second

Amended Complaint be dismissed with prejudice, and that judgment be entered for Landesman;

2. That Defendants be awarded their costs of suit; and

3. That the Court grant such further relief as the Court may deem just and proper.
