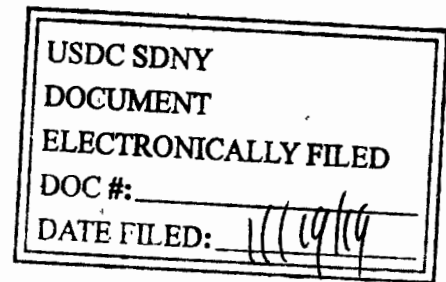


**MOTION TO ADMIT A. NEILL THUPARI**



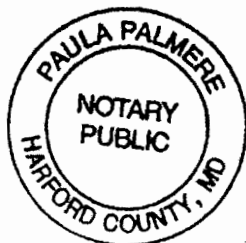


