1. I am a Senior Managing Director of Goldin Associates LLC (“Goldin”) located at 350 Fifth Avenue, New York, New York.

2. This declaration is based upon my personal knowledge and information provided to me by other Goldin professionals. I am in all respects competent to make this Declaration.

3. On July 11, 2017, I submitted a Declaration in Support of the Application of the Receiver for an Order Approving the Retention of Goldin Associates, LLC, Nunc Pro Tunc, to the Appointment Date (“Original Declaration”).

4. On July 21, 2017, the Court issued an Order authorizing Melanie Cyganowski, the Receiver in this matter, to retain Goldin.

5. The terms of the Original Declaration are incorporated by reference as if fully set forth herein.

6. Effective August 24, 2020, Goldin Associates, LLC was acquired by Teneo Capital, LLC (“Teneo Capital”).

7. Teneo reviewed the parties at interest (“Interested Parties”) Goldin provided for conflicts and connections with Teneo Capital and affiliated entities within its corporate family.

8. Goldin also conducted a follow-up review of the Interested Parties.

9. Based on the results of the Teneo and Goldin reviews described herein, I submit this Supplemental Declaration to provide the following additional disclosure:

- a. BDO provides services to Teneo Capital and affiliates unrelated to the Platinum receivership.
