**NOTICE OF RECEIVER’S CLAIMS ANALYSIS REPORT**

**PLEASE READ THIS NOTICE AND THE ATTACHMENTS HERETO  
CAREFULLY AS YOUR SUBSTANTIVE RIGHTS MAY BE AFFECTED BY THIS  
NOTICE.**

**IF YOU HAVE FILED A PROOF OF CLAIM IN THE ABOVE-CAPTIONED CASE,  
YOU SHOULD LOCATE YOUR NAME AND YOUR CLAIM(S) IN THE  
ATTACHMENTS HERETO.**

**PLEASE TAKE NOTICE** that pursuant to the Court’s December 1, 2020 *Order Establishing the Receiver’s Claims and Interests Reconciliation and Verification Procedures* [Dkt. 554] (the “**Verification Order**”), the Court authorized Melanie L. Cyganowski, as Receiver (the “**Receiver**”) for the Receivership Entities,<sup>1</sup> to file and serve a Claims Analysis Report setting forth the Receiver’s determinations with respect to each Filed Claim.<sup>2</sup>

**PLEASE TAKE FURTHER NOTICE** that attached to this Notice are schedules that comprise the Receiver’s Claims Analysis Report, setting forth the Receiver’s determinations with respect to each Filed Claim, including the allowed amount of the Claim, if any, the Receivership Entity the Claim is allowed against, and whether the Claim is secured by property of a Receivership Entity.

**PLEASE TAKE FURTHER NOTICE** that if you have not timely submitted a Filed Claim pursuant to the Bar Date Orders, you will not be identified in the attached schedules, and are not entitled to receive a distribution under a plan of distribution.

**PLEASE TAKE FURTHER NOTICE** that if you hold an Interest in a Receivership Entity, you will not be identified in the attached schedules, but will receive an Investor Statement in accordance with the Verification Order.

**PLEASE TAKE FURTHER NOTICE** that the Receiver has determined it appropriate to categorize Filed Claims so that certain Claims are grouped together for purposes of this Notice. In particular, the Receiver has categorized each Filed Claim into one of two broad categories: (1) Claims against PPCO Funds and non-Receivership Entities; or (2) Claims against PPLO Funds. Within each of these two broad categories, for purposes of this Notice, the Receiver has further categorized Claims into the below categories, which are each set forth in a separate schedule attached to this Notice. Additionally, attached as **Schedule A** is a key of the entities that Filed Claims were asserted against in the Receivership.

The Receiver has categorized Filed Claims into the following categories:

1. **Schedule B: PPCO Allowed Claims.** These Claims are Claims that the Receiver has determined to allow or allow in-part against PPCO.
2. **Schedule C: PPCO Insider Indemnification Claims.** These Claims are Claims asserted against PPCO Funds for indemnification of insiders of certain of the Receivership Entities that the Receiver has determined to allow in-part against PPCO or disallow.

5. **Schedule F: PPCO Settled Claims.** These Claims are Claims that the Receiver has settled with the applicable Claimant in connection with PPCO Funds.
6. **Schedule G: PPLO Allowed Claims.** These Claims are Claims asserted against PPLO Funds that the Receiver has determined to allow or allow in-part against PPLO.
7. **Schedule H: PPLO Insider Indemnification Claims.** These Claims are Claims asserted against PPLO Funds for indemnification of insiders of certain of the Receivership Entities that the Receiver has determined to allow in-part against PPLO or disallow.
8. **Schedule I: PPLO Employee Claims.** These Claims are Claims of alleged employees of certain of the Receivership Entities that the Receiver has determined to allow or allow in-part against PPLO, or disallow.
9. **Schedule J: PPLO Denied Claims.** These Claims are Claims asserted against PPLO Funds that the Receiver has determined to disallow.

**PLEASE TAKE FURTHER NOTICE** that where applicable, each schedule includes the Receiver's basis for the Receiver's determinations regarding each Claim listed in the schedule.

**PLEASE TAKE FURTHER NOTICE THAT THE AMOUNTS REFLECTED IN THE ATTACHED SCHEDULES DO NOT REPRESENT THE AMOUNT YOU WILL RECEIVE ON ACCOUNT OF YOUR CLAIM(S), IF ANY. THE EVENTUAL DISTRIBUTION OF FUNDS WILL BE SUBJECT TO THE RECEIVERSHIP'S TOTAL ASSETS AVAILABLE FOR DISTRIBUTION AFTER THE COURT APPROVES A DISTRIBUTION PLAN.**

**PLEASE TAKE FURTHER NOTICE** that any Objections to the Claims Analysis Report shall (i) be in writing, (ii) state your name and address, the name and address of your counsel, if any, the assigned claim number, and the nature of your Filed Claim(s), (iii) state with particularity the basis and nature of all objections, and (iv) be electronically mailed to the Receiver, at her email address, [platinumreceiver@otterbourg.com](mailto:platinumreceiver@otterbourg.com), so as to be **actually received not later than 45 days after the date of this Notice**.

**PLEASE TAKE FURTHER NOTICE** that Objections should not be filed with the Court.

**PLEASE TAKE FURTHER NOTICE** that if you fail to object to the Receiver's determinations as to your Claim(s) as set forth in the attached schedules, then you will be permanently precluded from objecting to the information in the schedules and the Receiver's determinations set forth in the schedules shall be final and binding. The information in the schedules will be used to calculate the distribution that you may receive pursuant to any approved plan of distribution.

**PLEASE TAKE FURTHER NOTICE** that if you, or your counsel, timely submit an Objection, a representative of the Receiver will contact you or your counsel to attempt to resolve your Objection in accordance with the Verification Order, which may include, with your consent, submitting the dispute to mediation.

**PLEASE TAKE FURTHER NOTICE** that any disputes concerning your Claim(s) that cannot be resolved by agreement between you and the Receiver will be adjudicated by the Court in a summary proceeding, commenced by the Receiver in which you will have an opportunity to be heard before the Court.

**PLEASE TAKE FURTHER NOTICE** that the Receiver reserves the right to propose a plan of distribution that provides for different classes of Claims and Interests and treats each in any manner the Receiver determines to be equitable, including the subordination of certain class or classes of Claims or Interests and the method of calculating distributions to Investors and Claimants. Investors, Claimants, and other parties in interest will have the opportunity to object to the plan of distribution and any of its provisions, including the distribution methodology and treatment of Interests and Claims, in connection with the requested approval of the plan of distribution.
