Dear Judge Cogan:

We represent defendant David Levy in the above-captioned matter.

We write in connection with the Receiver's Omnibus Motion to confirm her claim determinations, which was filed on November 23, 2021 (Dkt. No. 602). Pursuant to the agreement of all the parties to this motion – which is contested -- the claimants' oppositions to the omnibus motion are due on December 13, 2021 (*see* Dkt. No. 597). This morning, an ECF notification indicated that the Court had granted the omnibus motion. I have communicated with the Receiver's counsel who has agreed that the ECF notification should be withdrawn, and who has again confirmed that the claimants' opposition papers are due on December 13, 2021. Accordingly, we respectfully request that Dkt. No. 606 be withdrawn.

In addition, pursuant to Rule III.B.1 of Your Honor's individual practices, we respectfully request permission for an extension of the twenty-five (25) page limit for Mr. Levy and non-party claimant Wilson Sonsini Goodrich & Rosati, P.C.'s ("Wilson Sonsini") memorandum of law in opposition to the Receiver's omnibus motion. This Court previously granted the Receiver's request to file an oversize omnibus memorandum of law in support of the aforementioned motion not to exceed sixty-five (65) pages (*see* Dkt. No. 594 and Oct. 9, 2021 Order), which Mr. Levy consented to. Given the length and variety of the Receiver's arguments, Mr. Levy and Wilson Sonsini request permission for a limit of no more than thirty-seven (37) pages for their combined opposition brief. We have conferred with counsel for the Receiver, who has consented to this request.
