Pursuant to Local Civil Rule 1.4, I respectfully request the withdrawal of my appearance on behalf of the Movants Zanhav Holding LLC and Piping Brook LLC (“Movants”). I further request that the email address pkingsbery@ck-litigation.com be removed from the ECF service notification list for this case.

In 2018, Dechert LLP represented Movants in connection with their objections to the Receiver’s Motion for Entry of an Order Approving the Sale of the Receivership’s Rights in and to the Gold Tailings Pond, Known as “Abdala” (ECF No. 357) (the “Sale Motion”). By letter dated September 7, 2018 (ECF No. 379), Movants withdrew their objections to the Sale Motion through their counsel, Dechert LLP.
