**AMENDED DECLARATION FOR REQUEST FOR CERTIFICATE OF DEFAULT**

WARREN E. GLUCK, declares under penalty of perjury, in accordance with the provisions of 28 U.S.C. § 1746, as follows:

1. I am a partner at Holland & Knight LLP, attorneys for Plaintiffs Martin Trott and Christopher Smith, as Joint Official Liquidators and Foreign Representatives of Platinum Partners Value Arbitrage Fund L.P. (in Official Liquidation), and for Platinum Partners Value Arbitrage Fund L.P. (in Official Liquidation) (together, “Plaintiffs”), in the above-captioned actions.

2. I respectfully submit this Amended Declaration in Support of Plaintiffs’ request, pursuant to Federal Rule of Civil Procedure 55(a) and Local Civil Rule 55.1, that the Clerk of the Court issue a Certificate of Default for Defendant Platinum Management (NY) LLC (“Platinum Management”). Platinum Management is not an infant, in the military, or an incompetent person.

3. On November 21, 2018, Plaintiffs filed a Summons and Complaint in the action captioned *Trott v. Platinum Management (NY) LLC, et al.*, 1:18-cv-10936 (JSR) (the “Trott Action”). Trott Action, ECF No. 1. A copy of the summons and complaint was personally served on Platinum Management via Heather Howie, an employee at VCORP Services, LLC, which is Platinum Management’s registered agent for service, on December 27, 2018, and proof of service was therefore filed on January 22, 2019. *See* Trott Action, ECF No. 140.

4. On January 25, 2019, Plaintiffs filed a First Amended Complaint in the Trott Action against, among others, Platinum Management. *See* Trott Action, ECF No. 159.

5. Prior to service of the FAC, on February 25, 2019, Saul Feder filed a Notice of Appearance on behalf of Platinum Management. *See* Trott Action, ECF No. 255.

6. Subsequent to the Court consolidating the Trott Action with the related actions captioned *In re Platinum-Beechwood Litigation*, 18-cv-6658 (JSR) (ECF No. 94) (together with the Trott Action, the “Consolidated Actions”), Plaintiffs filed the operative Second Amended Complaint (“SAC”) against, among others, Platinum Management on March 29, 2019. *See* Trott Action, ECF No. 285.

7. Platinum Management was served with the SAC on March 29, 2019 by the Court’s Electronic Case Filing System, which constitutes service upon Feder.

8. On August, 25, 2020, Saul Feder, Platinum Management's counsel, filed a motion seeking to withdraw as counsel for Platinum Management (the “Motion to Withdraw”). *See* Trott Action, ECF No. 652.

9. Also on August 25, 2020, on a teleconference involving counsel for Plaintiffs, Saul Feder, and others, the Court, as a result of the Motion to Withdraw, instructed Plaintiffs to move for a default of Platinum Management no later than September 11, 2020.

10. On August 28, 2020, the Court granted Feder's Motion to Withdraw and relieved Feder as counsel for Platinum Management. *See* Trott Action, ECF No. 656.

11. On September 11, 2020, Plaintiffs filed a Proposed Clerk's Certificate of Default, pursuant to Federal Rule of Civil Procedure 55(a), and Local Civil Rule 55.1, for a certificate of default against Platinum Management. *See* Trott Action, ECF No. 659.

12. On September 14, 2020, the Clerk requested that Plaintiffs refile the proposed certificate of default.

13. Platinum Management has failed to plead or otherwise defend in the Trott Action or the Consolidated Actions. The time within which Platinum Management may answer, plead or otherwise defend this action has expired and such time has not been extended by any stipulation of the parties or any order of the Court.

WHEREFORE, Plaintiffs respectfully request that the Court issued the proposed Certificate of Default against Platinum Management submitted herewith.
