
MOTION TO ADMIT KATHLEEN A. BIRRANE *PRO HAC VICE*



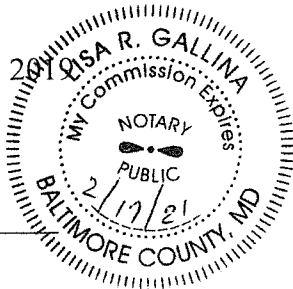
