
**MOTION TO ADMIT JAMES D. MATHIAS PRO HAC VICE**



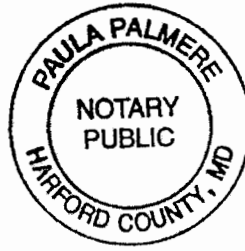

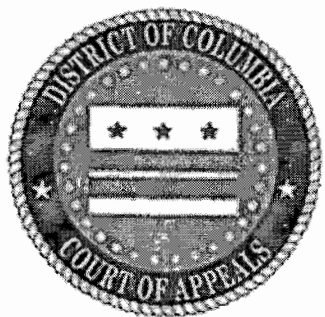
