1. I am a partner of the law firm of Quinn Emanuel Urquhart & Sullivan, LLP and a member in good standing of the bar of the State of New York and this Court. I respectfully submit this declaration pursuant to Local Rule 1.4 in support of the accompanying proposed consent order substituting Quinn Emanuel as counsel of record for Defendants Platinum Management (NY) LLC and Mark Nordlicht.

2. As reflected in the proposed consent order, Platinum Management (NY) LLC and Mr. Nordlicht have requested that Quinn Emanuel represent them in this matter and have consented to the substitution of counsel.

3. Platinum Management (NY) LLC's and Mr. Nordlicht's current counsel, Dechert LLP, also has consented to the substitution. Dechert is not asserting a retaining or charging lien.

4. The Complaint in this case was filed on December 19, 2016. That same day, the Court entered an order appointing a receiver for, among other entities, Defendant Platinum Credit Management, L.P.
