
**MOTION TO ADMIT ELLEN E. DEW PRO HAC VICE**



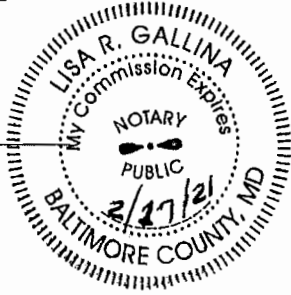

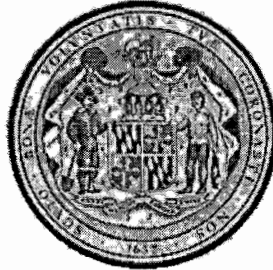
