DECLARATION OF TREY ROGERS IN FURTHER SUPPORT OF THE RECEIVER'S MOTION FOR ENTRY OF AN ORDER (I) (A) AUTHORIZING THE RECEIVER TO SELL THE RECEIVERSHIP'S RIGHTS IN AND TO LC ENERGY OPERATIONS LLC FREE AND CLEAR OF ALL LIENS, CLAIMS, ENCUMBRANCES AND OTHER INTERESTS; (B) APPROVING PROCEDURES FOR THE FILING OF CLAIMS AGAINST LC ENERGY AND/ OR ITS ASSETS AND THE RESOLUTION THEREOF AND (C) GRANTING CERTAIN RELATED RELIEF AND (II) APPROVING THE SALE OF LC ENERGY FREE AND CLEAR OF ALL LIENS, CLAIMS, ENCUMBRANCES, AND OTHER INTERESTS

- I, Trey Rogers, pursuant to 28 U.S.C. § 1746, hereby declare that the following is true to the best of my knowledge, information and belief:
- 1. I make this declaration in my capacity as the Chief Financial Officer of Platinum Credit Management, L.P. ("*Platinum Management*"), one of the entities placed into receivership by this Court, along with Platinum Partners Credit Opportunities Master Fund LP, Platinum Partners Credit Opportunities Fund (TE) LLC, Platinum Partners Credit Opportunities Fund LLC, Platinum Partners Credit Opportunities Fund (BL) LLC, Platinum Liquid Opportunity Management (NY) LLC, Platinum Partners Liquid Opportunity Fund (USA) L.P.,

Platinum Partners Liquid Opportunity Master Fund L.P., Platinum Partners Credit Opportunities Fund International Ltd and Platinum Partners Credit Opportunities Fund International (A) Ltd (collectively with Platinum Management, the "*Receivership Entities*").

- 2. I submit this declaration in further support of the December 6, 2018 motion for an order (I) (a) authorizing Melanie L. Cyganowski (the "*Receiver*") to sell (the "*Sale*") the Receivership's rights in and to LC Energy Operations LLC and/ or its assets ("*LC Energy*") free and clear of all liens, claims, encumbrances and other interests (collectively, "*Encumbrances*"); (b) authorizing the Receiver to enter into a stalking horse agreement and approving certain bid protections in connection therewith; (c) approving the form and manner of notice of the Sale; (d) approving certain procedures for the filing of claims against LC Energy and the resolution thereof and (e) approving bid procedures for the sale of LC Energy upon the selection of a stalking horse and (II) approving the sale of LC Energy free and clear of all Encumbrances (the "*Motion*"). Dkt No. 422.<sup>1</sup>
- 3. As Chief Financial Officer of Platinum Management, I work for the Receiver who has been vested with "all powers, authorities, rights and privileges heretofore possessed by the officers, directors, managers, managing members, and general and limited partners of the Receivership Entities under applicable state and federal law ..." See ¶ 3 of the October 16, 2017 Second Amended Order Appointing Receiver, Dkt. No. 276.
- 4. As part of my duties as Chief Financial Officer of Platinum Management, I track all expenses paid by the Receivership Entities.
- 5. I understand that through the Motion, the Receiver requests this Court's authority to, among other things, reimburse PPCO from the proceeds of the Sale for (i) the DIP Loan and

6. After the Motion was filed, the Receiver requested that I review all post-

receivership costs and expenses the Receivership Entities paid for, or on behalf of, LC Energy

(the "Receivership Expenses") so that upon a Sale, those amounts could be reimbursed to PPCO.

Expenses, which as of the date hereof total \$2,952,281.53. This figure supersedes and replaces

the figure previously set forth at Paragraph 30 of the Declaration of the Receiver in support of the

422.
