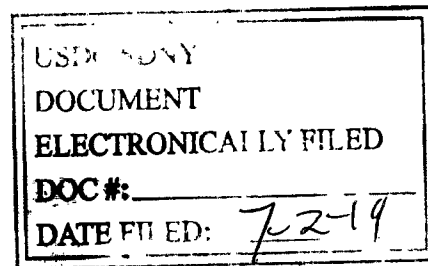

WHEREAS, Saks' last day to answer the SAC is currently July 5, 2019;


